Registration Information

Stock Classes: Vehicle may not have any modifications listed under the definition of Modified classes. Vehicles should have a stock appearance. No more than 3 of the following changes will be allowed in the stock classes; non-stock appearing intake/carb/efi, exhaust manifolds, headers, wheels/tires (within appropriate size range and style to be age appropriate and to be consistent with a stock appearance), ignition, radiator, AC compressor, auxiliary gauges, battery cables and other items considered as minor. If more than three changes are noted during judging, the score for the vehicle may be adjusted downward. In addition to these items, paint will not have to match an OEM color, but should be done in a manner that does not distract from the stock appearance. If two or more vehicles are considered tied during judging, the most stock appearing vehicle will prevail. Vehicles enter in the Unrestored/Survivor class may not have more than one exterior panel (or equivalent area) be repainted; one seat cushion replaced, minor engine work, etc.

The POCC Chief Judge reserves the right to make the final determination whether a vehicle is assigned to a Stock, Semi-modified and Modified Class and to make class changes without notice. The Chief Judge's decisions shall be regarded as final.

Semi-Modified Classes:

Vehicles must have a stock appearance but minor changes exceed the three allowed in the Stock Class.

P: To 59 Pontiac, Oldsmobile, Buick, Cadillac

Q: 60 and up Pontiac, Oldsmobile, Buick, Cadillac

Modified Classes:

Vehicles may have any modification beyond those allowed in the Semi-Modified Class.

R: To 59 Pontiac, Oldsmobile, Buick, Cadillac

S: 60 and up Pontiac, Oldsmobile, Buick, Cadillac
